Call us on 01737 644 288 and we will be happy to discuss your course requirements. Also check our website where you can view the most recent course dates and full course information.

Course fees

A minimum deposit of 50% is required to confirm a booking. A booking is confirmed when the payment and completed booking form are received by the Aqua Sports Company. The balance is due 14 days before course commencement. Full payment is due at the time of booking if booking is made within 14 days of course.

Client Course Cancellation/ Postponement

In the even of cancellation, notice must be received in writing 14 days prior to the course date and a cancellation fee of £35 will be incurred. Cancellation within 14 days of a course will result in loss of remittance. Clients failing to attend courses without notification will forfeit their remittance. In the even that a client wishes to postpone attendance on a course, an administration fee of £25 will be incurred and a minimum of 48 hours notice is required. For changes made less than 48 hours before the course, Aqua Sports reserves the right to charge the full cancellation fee of £35.*

Offers and Course Packages

'Fastrak' packages must be completed within 12 months. Packages count as one course: refunds cannot be given in the event of cancellation of a second or third part of an offer package.

Centre Course Cancellation

We reserve the right to postpone a course or part of a course as a result of unsuitable conditions, or other circumstances outside Aqua Sport's control. In this event a mutually convenient date to reconvene will be arranged. In the event that course minimum numbers are not met, where possible personal tuition may be offered for a shorter period of time with free hire, or the course will be rolled over to a mutually convenient date, or a course voucher will be offered.

Insurance
